

# ADVICE FOR POSTDOCS BEGINNING RESEARCH IN THE GROUP

## 2. GETTING HELP!

I am almost always available by email. You can make an appointment to meeting in person or by google hangout other times. Just check my calendar at <http://fox-kemper.com/contact> and suggest an open time that works for you.

I will be contacting you to schedule group meeting times, and I expect for you to come to group meeting if possible. I will schedule it to avoid classes, childcare, etc., as best as possible.

The lab group is also available to you for questions, giving and getting advice, and support. They are already highly trained in science, and part of what you are learning now is how to advise. They need to learn from you as much as you need to talk to them! To put it another way, a post-doctoral scientist is only about 2 years away from being a professor, and a senior graduate student is only 5 years away, so now is a great chance to give and get advice and learn how they think. You will be attending group meetings regularly: Speak Up and Ask Questions!

## 3. EXPECTATIONS

### **3.1. Baylor's Responsibilities.**

- (1) Advice on research, such as this document and lots of conversations about your direction, opportunities, and available resources.
- (2) Being supportive of who you are, what you are trying to accomplish, and who you are trying to become. This applies to research, administration, teaching, and other aspects of university life.
- (3) Pursuing funding for you and your research needs, including sponsored research opportunities (federal and foundation grants), helping you with fellowship applications, travel, conference fees, specialized computing, etc.
- (4) Being responsive on co-authoring papers, posters, and presentations.

- (5) Assisting you in contacting collaborators and preparing to do so at conferences.
- (6) Being available to discuss research challenges.
- (7) Recommending reading and conferences for your research direction.

### 3.2. What Baylor expects from you.

- (1) Getting involved! Come to lab meetings, ask questions, read papers distributed to the group, and look for opportunities to participate.
- (2) Mentoring and collaborating with other postdocs and students in the group.
- (3) Trying to reflect your present understanding accurately—you are learning to be just enough confident, neither overconfident nor unappreciative of your potential and present knowledge.
- (4) Reporting your progress for others. This might be as simple as a lab notebook, jupyter notebook, conference poster or slides, or commented piece of code or dataset uploaded to Baylor’s google drive or the Brown Digital Repository (<https://repository.library.brown.edu>), or as sophisticated as a published paper (<https://fox-kemper.com/pubs>), but your time in the lab will be limited. We want to build on your successes, not lose them when you go!
- (5) Scheduling one-on-one meetings as you need to gain advice from Baylor *and others*.
- (6) Taking the responsibility of your job being funded, by taxpayers, philanthopists, or Brown, seriously. Including overhead and fringe benefits paid on your behalf, this funding is in excess of a \$100,000 per year, i.e., an excellent salary for an entry position. Treat it like one.

## 4. GENERAL COMMENTS: WHAT IS RESEARCH?

You have already completed a great deal of independent research, and are a leading expert in one or more subdisciplines. Over the next two years or so, you have the opportunity to do as much work as before or more without the interruptions of classes, proposals, or teaching. The work you do during these years may be the best of your career!

This opportunity can be formative, changing your life for the better and leading to your true passion! Or, it can be a letdown—not every conversation you’ll have or article you read will blow your mind, and there is enormous frustration involved in being a postdoc. It may be that you are upset by the slow pace of getting your thesis work published. It may be that you are changing subdisciplines, and learning the new field is slower than you expect. It may be that you are worried about the next stage, and writing applications and preparing for job interviews, etc., is taking up too much of your attention and time. Or, it may be that your family life is changing, and the needs of partners, children, and aging parents are adding to your stress.

Many, many postdocs experience an emotional slump in comparison to the triumphant feeling of finishing a Ph.D. Some never regain their equilibrium, and end up dropping out of science or settling for positions where they are not fulfilled regardless of their scientific potential. I want you to be as happy and productive as you can be during your postdoc and later career, and avoiding or minimizing this slump is the reason for this document.

Think about the work “research.” It means searching repeatedly. This thought is a good way to approach research. Just as “fishing” is not the same as “catching,” we should not confuse research with the much more rare discoveries and breakthroughs that drive the process.

**4.1. The Scientific Method.** We all learned the basic scientific method in school—hypothesis, prediction, experiment, theory—but real research is quite a bit more fluid and free-form (even though we often write a revisionist chronology of what happened in the lab to fit the method and this re-evaluation is critically important in finding errors and building a logical framework). There are, however, major pitfalls which can occur in the more unstructured process. I include a quotation from Popper (1998), who spent his life analyzing the difference between science and pseudoscience.

These considerations led me in the winter of 1919-1920 to conclusions which I may now reformulate as follows:

- (1) It is easy to obtain confirmations, or verifications, for nearly every theory—if we look for confirmations.
- (2) Confirmations should count only if they are the result of risky predictions; that is to say, if, unenlightened by the theory in question, we should have expected an event which was incompatible with the theory—an event which would have refuted the theory.
- (3) Every ‘good’ scientific theory is a prohibition: it forbids certain things to happen. The more a theory forbids, the better it is.
- (4) A theory which is not refutable by any conceivable event is non-scientific. Irrefutability is not a virtue of a theory (as people often think) but a vice.
- (5) Every genuine test of a theory is an attempt to falsify it, or to refute it. Testability is falsifiability; but there are degrees of testability: some theories are more testable, more exposed to refutation, than others; they take, as it were, greater risks.
- (6) Confirming evidence should not count except when it is the result of a genuine test of the theory; and this means that it can be presented as a serious but unsuccessful attempt to falsify the theory. (I now speak in such cases of ‘corroborating evidence’.)
- (7) Some genuinely testable theories, when found to be false, are still upheld by their admirers—for example by introducing ad hoc some auxiliary assumption, or by re-interpreting the theory ad hoc in such a way that it escapes refutation. Such a procedure is always possible, but it rescues the theory from refutation only at the price of destroying, or at least lowering, its scientific status. (I later described such a rescuing operation as a ‘conventionalist twist’ or a ‘conventionalist stratagem’.)

One can sum up all this by saying that the criterion of the scientific status of a theory is its falsifiability, or refutability, or testability.

Another take on the scientific method comes from Stewart et al. (2010):

Pioneered by ancient Greeks, developed by medieval Muslims, systematized in the Renaissance, perfected in the Enlightenment and patented by the Dupont Corporation, **the scientific method** improved on man’s previous tradition: making shit up. The scientific method added the crucial step of **experimentation**, using real-world data to test a **hypothesis** that, if proven, would be accepted by scientists as a **theory**, which could then be used to get a **grant**, or in some cases, **tenure**.

**4.2. Building a Research Program.** You have already received lots of training in fundamentals and experience in research. You probably have solved lots of problems and answered many questions.

However, you will be building on your ability to formulate your own questions that need answers into a program of related classes of problems that need answers. A major aspect of research that is confusing is that most of the time doing research is not spent answering questions, it’s spent figuring out what the right questions to ask are.

You will need to produce, quickly and effectively, new results that reveal the kind of scientist you are and can be. Some of these may be related to the project you are hired on, some may be related to your thesis work, and some may be outside of these projects. I do not expect you to drop everything and work only on our project, nor do I expect you to ignore the project and do whatever you want. You are capable of seeing the opportunities to get things accomplished, when a model or calculation is ready, and you must take advantage. I only ask that you properly credit my contributions, and the support of whatever grants of mine you are on, in the papers you are writing.

You may work with me on proposals during your time as a postdoc, which is likely to be a major part of your career soon. Proposals are bigger than a paper, bigger than a Ph.D. thesis, and often bigger than what you can do on your own (i.e., involving collaborations). The art of writing a proposal that is fundable takes practice, and it is different from writing a paper (where the answers are already known).

What makes for a good proposal? 1) *It should be something for which you are prepared* (e.g., it might involve adapting a method you have already applied to a different problem), or at least you know how to

become prepared (e.g., another lab member might know the method and can teach you, or you might have a paper or textbook describing it, or you might have inherited some computer code that solves a similar problem). 2) *It should be interesting to you.* You will work harder on this than anything academic you've done so far, and you will need to convince others that it is important. 3) *The solution to the problem should be useful to others.* Baylor and the lab group can help you out here. You will have opportunities at conferences to further hone your audience and direction, by seeing the larger community and sensing what of your work interests them. 4) *It should seem, at first glance, to be both obviously achievable by you and impossible for anyone else to even consider being able to do it.* Good research problems start small, with a simple question that can be clearly posed. If you do solve it in a day, then *awesome!* You can generalize your question to make it harder! If it's too hard to begin with, then you're stuck with zilch. You need to argue for at least the possibility, if not the certainty, that results—whether they confirm or refute your hypotheses—will be of use to the wider community. In a proposal, you are also arguing that you are uniquely, or at least adequately, skilled to take this problem on.

**4.3. Do I work for Baylor, or is he teaching me, or am I independent?** All. You are funded by a grant that was proposed by Baylor to address a particular science question, or you have a fellowship that was obtained premised on working with Baylor, so you work for Baylor. However, you are writing collaborative papers, learning about career options, and training to teach, so you are being taught. You are also writing first-author or your own papers, going to meetings on your own, building an independent collaborative network and career base, and making discoveries that only you can. Such bureaucratic distinctions are pretty meaningless, since Baylor is often teaching you and learning from you, and the expectation is that you are both independent and a collaborator.

The best thing you can do is just get engaged with the project and the group. This will constitute both your job and your education. Getting engaged requires showing up, asking questions, actually reading the things that are suggested, and thinking about what they mean and if they are relevant. If you ask someone a question, it is on you to make sure you understand the answer: ask follow-ups later, see if you can reproduce the result, etc. Think about how such activities relate to your career goals—if you want to be a professor is this useful? Researcher? Undergraduate instructor?

**4.4. Collaborating.** One of the most important ways for you to develop your career is to build a collaboration network. These are scientists whom you respect and who respect you. They can write letters for your applications, co-author papers, give you data or code that will save you time, cite your papers, etc. Importantly, they will become your friends and community as you develop as a scientist. They will support you on a personal level, have meals with you at conferences, have running jokes, and generally make the process of doing research more fun and less lonely. How do you go about making these connections? Like making friends in the rest of your life, part of it is having shared interests, part is personal chemistry, part is having and acknowledging mutual respect, and part is not taking unfair advantage of that person's time, position, or research results.

Each interaction you have with your collaborators is important in building the relationship. One example is when you add them as a co-author or a conference abstract or paper. Here is a sample email you might send to them if you haven't met them yet.

Dear Prof. ???, (or Dr. ??? if they are a post-doc or researcher)

I am working with Baylor on a project related to your past collaborations with him. I intend to present in February at the 2016 Ocean Sciences on this work, and I'd like to acknowledge your contributions with a co-authorship. Please find the title, proposed session, author list, and draft abstract below. Any suggestions you have are most welcome!

Another example is acknowledging their work through offering co-authorships on papers or acknowledgments at the end of papers. I find it better to ask collaborators if they want to be co-authors if in doubt. If they refuse, or if their contributions were long ago or short-lived, then an acknowledgment is appropriate. Acknowledgments also *must* include a detailed list of funding sources for all authors. Often, using a computing center or other facility should be acknowledged, and if so they often give a preferred format on their webpage. Here is a (long) example from Haney et al. (2015) illustrating many of the types of credit:

Acknowledgments. 4.4.1. *Planning a Meeting.* Every meeting is an opportunity for you to either waste everyone’s time or make real progress and potentially have a eureka moment. Knowing how to set a meeting is an important skill. The convener or chair of the meeting is in charge of setting the agenda. It is important to make an agenda, especially so when there are many people coming to the meeting. For a few minutes of the convener’s time, 5 or 10 person-hours can be saved!

Here is a basic outline for a half-hour meeting:

- (1) Briefly review mood, function, status (1 min), e.g., “Suffering”, “Gangbusters”, “Stuck”
- (2) Bridge discussion from previous session with the current session (2 min), e.g., “Last time, we did ... and decided ...”
- (3) Set the agenda for the current session, and prioritize the items (2 min), “Today I want to ...”
- (4) Review any homework/action items given in the previous session (5 min), “I completed ..., but am still working on ...”
- (5) Discuss agenda items and set up new homework/actions (15 min): this is the main point.
- (6) Summarize the meeting and exchange feedback (5 min), “OK, we agree that ... You’ll do ..., and I’ll do ...”
- (7) Follow up with an email shortly afterward, “Here is my written understanding of exactly what we agreed, .... We’ll meet again on ...”

For longer meetings, multiply the times accordingly. If the meeting is a hour or longer, you should plan this agenda in advance and include it in your email invitation. You don’t have to prepare slides or a handout, but these can be very useful if you have lots of technical details that need to be right (e.g., figures of data, equations).

For academic committee meetings, annual reports, or other rare events, it is important to remember the “big picture.” Make sure to address all of academics, research, service, and teaching. It is important to produce slides for the meeting or a handout. You should email a copy of these to all participants in

advance of the meeting or shortly afterward. Include both what has happened ever in your life (briefly, i.e., 1 slide for all, e.g., Degree in . . . , High School . . . , From . . . , First Language . . . , Year in Program . . . ), and what has happened since your last meeting with most of the group participants (1 slide academics, 1 slide research). Then follow the rough outline above to address your specific goals for this meeting.

4.4.2. *Authorship of Papers:* The first principle of authorship in my group is that students and postdoctoral scientists should almost always lead the writing of the papers they participate in, which is officially encouraged by our department at Brown and my previous affiliations at the University of Colorado. This experience is critical for group member development, and they are often best at detailing the simulations they have run. First authorship indicates who is in charge of “seeing it through,” but substantial ideas and input are required from all authors (including myself, of course!). To help a reader identify credit in papers, on my curriculum vitae I indicate special authors with underlines, over-lines, and italics to distinguish senior group members, junior group members, undergraduate researchers, supported graduate students, postdoctoral scientists, and graduate students from other groups.

In climate modeling, it is common to collaborate with scientists at modeling centers or collecting observations. Many authors become involved in papers through contributions to the coding or experimental design. In 2015, *Ocean Modelling* has had fewer than 15% single-author papers, and *Journal of Climate* has had fewer than 5% with one author. Our papers usually have myself or a junior group member as lead, and then an alphabetical list of contributors afterward (e.g., Fox-Kemper et al., 2011; Fox-Kemper et al., 2013; Li et al., 2016). Similarly, when I consult on a graduate student’s research in a significant way, but not as primary doctoral advisor, I am usually listed near the end of the author list (e.g., Reckinger et al., 2012; Grooms et al., 2011; Qazi et al., 2014). Collaborative papers with equal partners are alphabetical (Boccaletti et al., 2007; Bates et al., 2012; Cavaleri et al., 2012). In cases where one author contributed significantly more effort, they are first author, then ordering is alphabetical (Jochum et al., 2009; Haney et al., 2012) or by significance of contribution (Belcher et al., 2012; McWilliams and Fox-Kemper, 2013). In some cases, the acknowledgment section of the paper explicitly details each author’s contribution (D’Asaro et al., 2014).

Deciding whether an authorship or an acknowledgement is appropriate can be hard, and hurt feelings are common in this department. If you are in doubt, discuss with Baylor. It is possible, though rare, that you can poison a research relationship by making a bad decision either way (including an author who doesn’t deserve it aggravates other partners and not including a collaborator who thinks they deserve to be are both trouble). The Vancouver criteria established by the International Committee of Medical Journal Editors is a useful reference of standards for authorship (<http://www.icmje.org>).

The ICMJE recommends that authorship be based on the following 4 criteria: 1. Substantial contributions to the conception or design of the work; or the acquisition, analysis, or interpretation of data for the work; AND 2. Drafting the work or revising it critically for important intellectual content; AND 3. Final approval of the version to be published; AND 4. Agreement to be accountable for all aspects of the work in ensuring that questions related to the accuracy or integrity of any part of the work are appropriately investigated and resolved.

In our field, ‘maybe’ cases of qualification 1 frequently result from a co-author sharing code or results that are not publicly available. Here, if in doubt ask the code contributor, because development of code is a thankless task that is not presently credited by academic bodies correctly. They may be comfortable with an acknowledgement or have a specific paper they’d like to you cite in the model description instead of a co-authorship. Point 2 is hard to assess in advance, but it should trigger a co-author to at least respond to your emails. Point 3 can significantly delay submission, so I recommend an ‘opt out’ rather than an ‘opt in’ email: i.e., “If I don’t hear from you by Friday, I will take it to mean that you are OK with the submission of the paper.” Point 4 is thus implied, but it, too, can be tricky if you undergo major revisions in the later stage of publications. You should always share your response to reviewers documents and a latexdiff or track changes version of the revisions with your co-authors if possible before resubmitting any

major revisions. These documents can be helpful to reviewers as well, so it is good practice to learn how to create them in your typesetting software. You should always email the submitted & accepted versions to all co-authors (and other interested parties, e.g., your thesis committee, grant co-investigators, and Baylor if he's not a co-author).

4.4.3. *How should I address collaborators and professors?* There are enormous regional variations in formality of address. Some places might require "Herren Professor Doctor X" in an email or even the classroom! You may have been raised or trained in such a place. Science in the US and at Brown is generally less formal, and you can always refer to Baylor by his first name. However, writing an email to a collaborator or editor that you don't know well does benefit from some formality to begin. You can then respond in later correspondences based on however they sign off on their responses to you. You are a PhD, though, so you can begin to expect colleagues to treat you as an equal.

4.5. **Using Your Faculty and Your Group.** As an post-doc, you should develop relationships with a wide group of faculty and researchers. Unlike when you were a student, these relationships will not be forced upon you through advisory committees or coursework. However, this does not mean you will not benefit from these relationships, it just means that it is up to you to seek them out. Find faculty and experts relevant to your research topic. Some of them will be potential collaborators, sharing very similar research interests, and some you may chose for breadth of science or just personal chemistry. Some may be outside of Climate & Environment, outside of DEEPS, or outside of Brown. It is important for you to build ways to contact these people about your work, which are useful, fun, and productive, but not distracting or overwhelming. They are in the ideal position to offer specific and general advice about your research direction and development as a scientist. You may send emails to them as significant developments occur, such as submitting a paper, winning an award, getting a model running, etc. You do not need to have a specific reason for them to reply, but they may surprise you with useful advice at such times. Importantly, you need to have such regular communication so that when you do need their advice your collaborative relationship is already healthy and functional (see the surrounding sections).

*Do not hesitate to schedule meetings in advance*, faculty are much more receptive when they know why you want to meet and when. Dropping by their office once or twice a year, and expecting spontaneous, yet brilliant advice is ridiculous. Send update emails regularly with no expectation of a response to keep them in the loop. If you need to request a meeting, do it in advance if possible and with an agenda specified in the request. It doesn't need to be formal, but "I'd like to talk to you about difficulties I'm having describing my model results in my thesis" and "I'd like to talk to you about my recent violent trauma" are both appropriate topics for meeting with a faculty advisor or friend. Obviously, however, they require different preparation on the part of the faculty member and such preparation is necessary for an optimal outcome. If your email just says, "Can we meet this week?", no preparation will occur.

You should also interact regularly and spontaneously with other group members, keeping in mind (of course) that they are busy, too. They will get to know your work well over time, and may be in a good position to help out with specific ideas and tips. I love for multiple group members and alums to be authors on papers; it signifies a successful internal model of collaboration.

4.6. **Integrity, Ethics, and Politics.** One of the most important ways that you can gain productive collaborations is through building of trust. You and I will be building trust through our work together, and this is true for any other collaboration as well. What does my trust in my scientific collaborators derive from?

- **A belief in their abilities and thoroughness:** I do not think they cut corners or approximate unduly or in unacknowledged ways.
- **A belief in their scientific integrity:** I do not think they are trying to deceive me or the readers of our papers. I do not think they are trying to claim credit for work that is not their own. I do not think they are trying to cast unfounded doubt on their competitors.

- **A belief in their scientific ethics:** I do not think they are likely to use our work together in ways that I would not approve of without discussion with me, such as encouraging destruction of the environment or development of weapons.
- **A belief in their willingness to report problems:** I trust them to tell me if they perceive a problem in my work, my students' work, or my collaborators' work. Even though such information may be inconvenient for me, I will act on it accordingly and not blame the messenger.
- **A belief that their politics do not trump their science:** In climate work, this can be a problem. It is important to understand when politically sensitive studies are occurring (e.g., our new result implies that the oceans are warming faster/slower than previous studies). On these kinds of projects, it is particularly important to mind scientific integrity, abilities, and thoroughness and to be as sure as humanly possible that these concerns override any political leanings members of the group may have.

You should be aware that I am working to hold myself to the highest standards on these fronts, and that I am evaluating you and our collaborators the same way. When you show me data, I expect you to accurately portray how thoroughly vetted it is. If it is likely to change under a different analysis, or you think there may be a bug, say so. If you have double-checked and triple-checked, but the results still are confusing or unexpected, say so! That may be a sign of the importance of the result. When you write a paper, it is often the case that details must be shortened or left out, and certain poorly understood exceptions must be handled. Interactions with peer reviewers often bring up such concerns. It is acceptable to reduce detail for the purpose of clarity (i.e., they are unneeded), it is not acceptable to reduce detail to cover up weaknesses of the approach or results.

I realize that you are still learning to navigate these waters, and may make unintentional mistakes with ethical or integrity consequences: no problem. However, if I learn that you (or any group member or collaborator) is intentionally falsifying results or hiding data that show disagreement, I will take direct action. This may include termination of my collaboration or your position, and will certainly include mention in any future opportunities that arise (recommendation letters, conversations at meetings, etc.).

**4.7. Am I Wasting My Time?** Being comfortable with muddling about a bit, or staring into the void of the unknown, is part of being good at research. You undoubtedly lost years of potential progress as a grad student to code bugs, misunderstanding of problems, getting scooped by other groups, etc. The expectation is that you are better at time management and getting to the meat of a problem than before, but that is no aegis against the fates of research. If you're stuck on research, do other productive work to get over the frustration: read the grad school handbooks (<http://bit.ly/1ISyNln>, <http://bit.ly/1hPOH2P>), or a book on careers (Fiske and Fiske, 2001; Vick et al., 2008) or writing (Turabian, 2013; Schimel, 2012; Glasman-Deal, 2010), or a report on new directions in oceans and climate (Goddard et al., 2013; Griffies et al., 2010; Fox-Kemper et al., 2018, 2021), or write something easy that can be included in other work later (a description of code you've written, summaries of papers you've read, etc.).

Many postdocs still lose track of time, run up too close to deadlines, get overwhelmed by self-doubt or feelings of inadequate progress, etc. So, here are some things to be on the lookout for, which can help you identify when you may be drifting from the winding path to progress to the path to missed opportunities.

Do you feel like avoiding Baylor or the group until you make more progress? This feeling is a key sign that you should do the opposite, and seek help or advice immediately. Often, just talking through your issues will clear the way, or give you the strength to make another push.

Have you checked anything off of your research list this week? If not, you probably have bitten off too much in one bite. Come talk to Baylor, or make a list with smaller, more achievable goals. If you don't have a list, make one and put "make research checklist" as the first item. That way, you get one goal checked off right away! Some weeks, especially those with exams, illness, travel, vacations, etc., will be less productive. That's okay, but two in a row is a problem, and a month is a major issue. If you go a month without checking something off of your research list, you are REQUIRED to meet with Baylor ASAP. If



you're stuck on research, do other productive work to get over the frustration: read a book on careers (Fiske and Fiske, 2001; Vick et al., 2008) or writing (Turabian, 2013; Schimel, 2012; Glasman-Deal, 2010), or a report on new directions in oceans and climate (Goddard et al., 2013; Griffies et al., 2010), or write something easy that can be included in other work later (a description of code you've written, summaries of papers you've read, etc.) or work on paper revisions from reviewers.

Have you charted out your deadlines? It is a good idea to find out early when a work document or proposal is due, when you have to register for a class or a conference, etc. It is the worst kind of research failing to forget a form after all of the hard work of getting results is done.

When did you last practice your elevator speech (i.e., 2 minute version of what you're working on)? This practice is part of our group meetings, but it is also part of your continual re-assessment of what you are doing and why it is important. As a scientist and educator, you need to be able to sell your ideas on the spot in person and in writing. Giving your elevator speech to diverse audiences is good practice at linguistic and conceptual gymnastics, and good career practice, too. Your elevator speech is *most important when you are looking for a permanent or long term position*, so you need to practice now more than ever.

Do you feel like you are constantly worrying about research progress, but your schedule is just too full with . . . ? This feeling is a different version of the avoidance behavior mentioned above. Procrastination or overscheduling yourself with fun or coursework or other non-research can be a sign that something isn't right about your research topic or approach. Group meetings, regular meetings with Baylor, and checklists with small, achievable goals are there precisely to catch these lapses and to help realign.

**4.8. Research Brings Up Lots of Feelings.** Most of the people I know who drop out of research do it because they have *emotional* issues with research, not trouble with skills, talent, or cleverness. You will not like everything you do in research. Some research tasks are frustrating, boring, smelly, nauseating, hard, and even painful. Researchers are usually rife with self-doubt, frustration, injury from perceived slights by colleagues, and the loneliness of working hard on something you can't explain to anyone. Getting comfortable with this emotional cycle, and celebrating the good, is part of what you are learning.

In fact, the American philosopher Peirce (1877) notes that feelings of doubt are required as a motivator for inquiry and the quest for truth rather than unfounded beliefs.

The irritation of doubt is the only immediate motive for the struggle to attain belief. It is certainly best for us that our beliefs should be such as may truly guide our actions so as to satisfy our desires; and this reflection will make us reject any belief which does not seem to have been so formed as to insure this result. But it will only do so by creating a doubt in the place of that belief. With the doubt, therefore, the struggle begins, and with the cessation of doubt it ends. Hence, the sole object of inquiry is the settlement of opinion. We may fancy that this is not enough for us, and that we seek, not merely an opinion, but a true opinion. But put this fancy to the test, and it proves groundless; for as soon as a firm belief is reached we are entirely satisfied, whether the belief be true or false. And it is clear that nothing out of the sphere of our knowledge can be our object, for nothing which does not affect the mind can be the motive for a mental effort. The most that can be maintained is, that we seek for a belief that we shall think to be true. But we think each one of our beliefs to be true, and, indeed, it is mere tautology to say so.

As a scientist you ought to lean toward doubting your beliefs, not doubting your doubts!

Piled Higher and Deeper (<http://www.phdcomics.com>) and Randall Munroe's xkcd comic (<http://xkcd.com>) are good ways to help laugh through the tears research sometimes brings. You can also talk to Baylor or seek counseling, in both cases earlier is better!

**4.9. Do I Like this Work?** The feelings just described are what research feels like for your whole career. As you mature, you will be more comfortable with the discomfort, and optimize how to seize and celebrate the joys, but research is never easy all the time. When your project or support window is completed, think about whether you feel like the good outweighs the bad. If it does, then go for it! If not, consider how

your next project or chapter might be better—less modeling? more fieldwork or observations? more/less statistics? more/less analysis? How can you write the next paper or proposal to be better or a better fit with you? Just because one project within your research oeuvre wasn't a good fit with you doesn't mean you don't like research as a whole.

**4.10. When Should I Expect Praise?** One topic that frequently comes up in discussions of department climate and student satisfaction is feeling overwhelmed by criticism instead of noticing the aspects of your science that have worked. Science is critical and sometimes antagonistic, deliberately, so that the truth comes out and missteps are revealed. However, science is also hard and requires effort, so good work should be noted and honored.

I try hard to point out the good aspects along with critiques. Preserving the good, e.g., during paper revisions, is as important as removing the bad. One standard approach from counseling and mentoring that I like is to provide a “compliment sandwich”. Start and end a conversation or email where critiques will be made with positive notes. Every meeting with me and every comment from me should contain both positive and critical comments. If you feel that's out of balance, let me know. It may be reflective of a needed change, possibly in your research direction but more likely in our working relationship.

However, that is oftentimes not enough when you are stuck or receive a bad review or grade. It can be good to check in with a friend, explicitly ask Baylor why he is optimistic about your research direction, or review your past successes that have led you to be here. It may surprise you, but I had to train myself to think gratefully while filling out annual reports or updating my CV, so I use these documents to recharge me. I frequently need the boost of confidence or reassurance to take on a difficult or irritating task.

**4.11. I Identify with a Group/Gender/Culture/Religion/Sexuality that is Uncommon in Science. Is It for Me?** Yes! You are just what is needed! Take a minute to think of all the ways your unique background will give you a different perspective and strengths as a scientist. These will help you to ask questions or find answers that no one else can!

However, some scientists and professors are socially incompetent and culturally ignorant. There have been studies showing that even well-meaning scientists who consider themselves allies and those who are themselves from underrepresented groups sometimes make decisions or judgments that are biased. This problem is not unique to the sciences. There may be times when you feel particularly wronged or need support. I am here to help. It might be through finding a relatable mentor, or utilizing resources from groups I work with such as <http://mpowir.org> and the Broader Impacts group of the Brown Science Center. It is my goal to build a more diverse scientific community, and supporting early-career scientists is critical.

Scientists being scientists, many scientists and science administrators are becoming convinced by the evidence from these studies. For this reason, there are increasing opportunities and a desire among scientists to expand the representation of underrepresented groups in the sciences. You can take advantage of these opportunities, and help to bring balance and the improved environment of a diverse workplace to the sciences. I have worked in more and less diverse labs, and diverse ones are the best!

**4.12. I have a Family/Personal/Learning Disability/Trauma/Health Issue that Affects My Schedule, Progress, Public Speaking, Writing, Etc.** No problem—it happens all the time. Just make a plan with Baylor about accommodations—early in the research relationship is better. Normally, you do not need to share any more details than you are comfortable with, and there is lots of flexibility in research that makes adaptation and mitigation easy.

**4.13. Applying to Jobs, Job Searches, and Interviews Bring Up Lots of Feelings.** Many of your feelings of self-doubt and anxiety just described are exacerbated when career decisions and evaluations are on the line. They can easily lead to procrastination; sleeplessness; drinking, drugs, and eating problems; writer's block; and whiffing interviews and examinations. The way to avoid this is to seek sympathy and empathy from family, friends, group members and colleagues, to be sure to celebrate with them what is

going well, and to keep exercise, eating, sleeping, and partying under control. It is a good idea to start early and small in preparing for these processes, talk to Baylor about how to begin.

The job season (November through March) is often a source of excessive worry for postdocs. The key is to constantly optimize your portfolio to balance significant results (from older work) with new ideas and groundbreaking results in a form that can be used. Remember, you already got one post-Ph.D. job, you will get another!

Don't be afraid to ask Baylor for recommendation letters after or during your project. You may be feeling unsure about how good the letter will be. Check out the "trust" section above and the next few sections for a better idea of what Baylor thinks about and writes in his letters.

**4.14. Clothing and Appearance.** You are in control of many aspects of your budding reputation as a researcher, and what you choose to wear is one aspect over which you have enormous control. As you know, scientists are frequently oddballs, and groups of scientists are definitely a 'mixed bag of nuts'. Unlike in the bad old days where dress codes were formalized and scientists were homogenous in gender and background, modern clothing choices require more thought. Scientists these days tend to be informal: I have heard earth scientists' clothing described as "ready at any moment to go hiking".

However, clothing can easily be productive or counterproductive. Good examples of productive clothing choices are: wearing clothes that are appropriate for the activity level (i.e., don't dress for swimming when going to a conference), show respect through an appropriate level of formality (e.g., job interviews and conference presentations should be a bit above the ordinary, but probably not the same as a wedding), and wearing clothes that make you recognizable. This last point is sometimes overlooked, especially by men, but I have heard many stories of scientists tracking down young scientists they don't know later at a conference based on a 'signature' item worn during their presentation (a scarf, a cheerful shirt or sweater, etc.). On the other hand, you don't want to stand out in a counterproductive way. You don't want to be wearing clothes that signal disrespect ("I really don't care, do u?"), or signal sexual availability more than scientific prowess, or are unpleasant or distracting to be around because they are dirty, smelly, or make everyone comment that you have dressed for the wrong weather.

There is also a lot of cultural baggage surrounding clothing, which may lead some scientists to wrong or uninformed conclusions. For example, consider the discussion of politicians needing 'gravitas', or being 'likeable' or 'articulate' to be electable. These are poll-tested code words that trigger misogynistic and racial stereotypes. I *am not* suggesting that you must give in to such stereotypes by diminishing who you are. I am suggesting you claim a degree of control in how you choose to operate given these conditions, which might actually be an appearance of protest if that is what suits you.

You may not know what to choose or choose inappropriately. Rest assured that this is a welcoming society, so it's probably OK no matter what, but if you feel uncomfortable or don't know what to choose do discuss with a friend you trust.

**4.15. Publish or Perish.** Academia really has only two goals: education and research. Plus, much of the university is engaged in seeing the results of these through to benefit the world. You are already aware of the education part, and probably also realize that academic degrees are the way that education is signified. Grades and transcripts play a much smaller role. Likewise, research is signified by the publication and dissemination of results. The gold standard is peer-reviewed articles or books, but conference presentations, theses, and other publications are also ways to establish a result on a firm footing where it can be communicated, shared, reproduced, and built upon.

Postdocs need peer-reviewed research publications much more than at other stages in their career, and their contributions are often leading these publications. You may also be working on projects with Baylor or other group members as lead. You will not be shorted on co-authorship, acknowledgments, etc. You will be in charge of balancing the level of responsibility and credit that you can handle. There are many opportunities for you to present at meetings, teach, and otherwise build your portfolio. Do not hesitate to ask to go to a meeting that Baylor doesn't know about, etc.

Why do we still do these things in the age of the internet? Can't we just tweet or blog every new formula as they come? No, because writing an article, or presenting at a conference requires a re-evaluation of the logic, techniques, flaws, and implications of research. This re-evaluation is as important in understanding a result as the result itself, and often only comes when things are written out. *You need to be on top of publishing your results quickly, as you will have even less time in your next job to catch up.*

If you stay in research, you will be judged on the basis of your publications. No one criterion will be dominant, but number, significance, skill, clarity, and drawing the attention of other scientists are all part of it. You might feel overwhelming pressure to write a report particularly well to incite good recommendation letters, etc. This pressure makes many people panic, causing writer's block, procrastination, etc. *Do not give in to this pressure. Change your writing plan, partners, get a second reader, convert a paper to a presentation and back, etc. Do not hesitate to give Baylor a hard time for being slow to do his part.*

To reduce the panic, try not to focus on what the writing says about you, but what it says about your research. Is this the best way to make your argument? Is there a clearer or simpler way to state your hypotheses? Who will read it? What do they need to know? If they want to reproduce your work, can they? Remember, the real reason why we publish is to present our results, not to promote ourselves. If you focus on getting and presenting results, the judging of you as a scientist will come naturally.

**4.16. What Does a Good Postdoc Research Outcome Look Like?** A good postdoc is one where thesis publications are completed early and well. During or soon afterward, new work is appearing, which may take the form of methods papers first, but builds to new ideas and a growing conception of your research agenda and style. You must distinguish yourself from your Ph.D. advisor and postdoctoral advisor. You will have ample opportunities to present each at conferences.

If you plan to find an educational position next, you will need to boost your credentials unless you have significant past teaching experience (e.g., teaching high school—being a TA is not enough). This is easy to do by covering classes for professors on travel, volunteering to help in short courses or seminars, etc. You do not have to sacrifice your research time or take on adjunct positions that involve complicated commutes, etc., but you should be on the lookout for easy ways to demonstrate your interest and growing maturity as a teacher. The Sheridan Center courses are another excellent example.

Do not hesitate to ask Baylor for advice in applying for jobs, updating your CV, seeking out teaching, etc. Your success in getting a good position helps recruit new successful postdocs to the group. Baylor has lots of books on the topic you can borrow (Fiske and Fiske, 2001; Vick et al., 2008).

Being a good colleague and collaborator is also an important part of the research experience. This means coming to group meetings and recommended research seminars, asking questions, participating in discussions, offering advice if you have it, and seeking out opportunities to learn, improve your research, and broaden your interests.

Collegiality also means behaving or learning to behave in a manner that leads to everyone being happy and productive. Pay attention to cues from group members: Are they too stressed to chat? Are you being too aggressive in critiquing their research? Just as bad, are you being too flattering, obsequious, or fawning instead of offering constructive criticism when they need it? Science, including our group, is a place for oddballs with weird behavior, interests, and unique tastes in clothing. Most importantly, discrimination, bullying, teasing, and prejudice are not tolerated. On the other hand, make yourself easy to be around in the lab. Don't wear stinky gym clothes or too much cologne. Be aware of how a messy workspace, messy eating, making too much noise, unplugging equipment, or failing to be on time is negatively affecting your interactions with the group. We have a fun, exciting, and casual work environment, but only because we all bring our best selves.

## 5. RESOURCES

Baylor has lots of experience teaching scientific reading, writing, and research and can get you started.

5.1. **Writing.** Baylor posts and collects sets of detailed instructions on scientific and other writing. Here is one example (<http://bit.ly/1JKVY2Y>). Lots of other great books are out there, too (Turabian, 2013; Schimel, 2012; Glasman-Deal, 2010).

5.2. **Figures and Visualization.** Just as with writing, you will spend inordinate amounts of time perfecting figures. Also just as with writing, the context and audience of figures is critically important to success—even more so with animations for online journals and presentations. There are lots of good books to help, and increasingly courses in scientific visualization. There is even a BA major program at RISD on scientific illustration! I’d recommend you try a short course if one comes your way, and I highly recommend reading Tufte (2001).

5.3. **Reading.** The joke is “hours of time in the library were avoided by months in the lab.” Seriously, there is excellent science written up out there with you as the intended audience! It is easily found through google scholar (<http://scholar.google.com>), the bibliographies of other papers or textbooks, or by asking other group members. If Baylor or group members advise you to read a paper, do it and you’ll learn!

As a rule of thumb, you should scan at least one new paper related to your research a week. Scientific reading is not the same as reading a novel or magazine article start to finish, because the style is intentionally formulaic for fast skimming. After you practice it will go quickly, just as reading the newspaper does. Baylor posts and collects sets of detailed instructions on scientific reading techniques. Here is one example (<http://bit.ly/1Nk1JNw>).

5.3.1. *Libraries.* You have access to a wide variety of online science when you are on the on-campus network. If you are off-campus, you can access the same resources by searching through <http://library.brown.edu/libweb/proxy.php>. You can also search for textbooks <http://josiah.brown.edu> or borrow them from Baylor. Please don’t keep his books forever; while he writes down who has what in a notebook, some of them still disappear.

5.4. **Math.** Lots of the research topics in the group are highly mathematical. Some good references are Boas (2006), Arfken et al. (2013), and Bender and Orszag (1999). Some of these have electronic versions (see bibliography). Baylor’s notes are also helpful (<http://bit.ly/107kZdQ>). Mathematica online (<http://bit.ly/1VHUduQ>) and Wolfram Alpha (<http://www.wolframalpha.com>) are excellent resources, and wikipedia is not bad either!

5.5. **Coding.** There is lots of coding in the group—FORTRAN, c++, Matlab, Mathematica, python, xcel, etc. We use various numerical models as well, on local machines, local clusters, and remote supercomputers. It’s a good idea to ask around and figure out who is working on a similar platform or with a similar model right away. It is also amazing how much you can figure out by cutting the text of an error into google!
